8. Head of School Report

Head of School, Randy Rodriguez, shared an enrollment update for MVCA. There has been steady enrollment growth 2019 through 2022. This data is based on the official head count day in October. The current November head count is 3,055 students.

a. Playbook Presentation – Elementary

Elementary Principal, Tanya Kuipers, highlighted what the elementary has been doing the past year. Literacy is the big focus. Three of the four chapters of the MVCA Playbook that encompasses literacy include Academic Achievement and Growth, Student Engagement, and Teacher Excellence. Mrs. Kuipers noted the continuous development of The Literacy Roadmap including Tiered Support and Informal Observations. The Tiered Support Plan is a focus on systematic, explicit instruction in whole group and small group. Tier I, II, and III instruction plans are put into place. Students are given extensive assessments such as DIBELS and STAR 360; teachers use the assessment data to inform their instruction. Through informal observations, evaluators look at teachers' academic rigor and how they plan coherent instruction with a focus on literacy skills. Teachers are coached and trained (LETRS and Orton-Gillingham Literacy) to further enhance student achievement. The elementary school implemented a 90-minute literacy block every day. Other effective changes include the integration of interventionists under the principals, implementation of MindPlay virtual literacy program, and reduction of classroom sizes. Mrs. Kuipers showed a video clip of a 1st grade teacher implementing a lesson using the Orton-Gillingham literacy approach.
