# 8. Head of School Report

Head of School, Randy Rodriguez, shared that MVCA staff are back in session for the 2022-2023 school year. MVCA had its professional development event in Lansing, Michigan, in which 175 staff members participated. This was the first time in three years that we were able to bring everyone together. The two-day professional development event has received raving feedback from staff about being face to face with the opportunity to see one another and having great content in their sessions. One staff commented that it felt more like a "revival" than professional development. Mr. Rodriguez also shared the administrative team will be present at next month's board meeting.

a. Student Support Team Presentation
 Amela Redzic, Student Support Team Administrator, shared information regarding what the
 Student Support Team (SST) supports and offers to MVCA students and families. The SST

work is aligned to MVCA's mission and vision of delivering hope. Mrs. Redzic shared that the SST focuses on the 5 E's: Engagement, Encouragement, Empowerment, Expectations, and Equip for both students and families. The Student Support Team consists of advisors and community engagement specialists, student attendance specialists, a McKinney Vento (homeless students)/Foster Care Liaison, and a student resource coordinator (social worker). Mrs. Redzic also shared that the programs the SST supported last year will continue this year. For example, students can request one on one sessions with counselors, Helpline sessions are available, and SEL sessions happen throughout the year through assemblies, homerooms, activities, and discussions. Last year, the SST supported 29 student clubs, 22 virtual events, and 4 face to face events, all with amazing attendance numbers. Other data Mrs. Redzic shared included that 1438 new students were successfully "onboarded" last year, and every new student is assigned an advisor. Over 1000 students were supported with back on track plans to help students stay focused on academic growth, passing grades, and engagement. There were seven clubs offered during summer among the elementary, middle school, and high school grade bands. Finally, Mrs. Redzic noted that "Strong Start" for the 2022-2023 school year has begun in which the SST and teachers are in the process of welcoming students, getting students logged on, and building student connections and engagement. Mrs. Redzic closed by saying it is a team effort to ensure students are ready to start school and everyone makes a difference for our students.

Mrs. Ann VanderLaan shared that she and Board President, Marva Foster, discussed the discipline hearing procedures found in the Student Code of Conduct and would like board feedback on revising the policy and procedure. The Board of Directors and Head of School, Randy Rodriguez, agreed that a student needing disciplinary action would have a hearing before the Head of School and the Head of School would give a disciplinary decision. A student may appeal a permanent expulsion decision to the Board of Directors, in which a student could present any evidence of specific policies not followed or any new information that was not presented in the previous hearing.
