a. Graduation Highlights

Head of School, Randy Rodriguez, shared highlights from MVCA's 2023 Graduation ceremony. The high school team and graduation organizer, Annie Butzu, did an outstanding job with this year's ceremony. The high school's focus on Creating Pathways for students was displayed in students' plans of either enrollment, employment, or enlistment. The commencement speech was delivered by high school principal, Dr. Laura VanDuyn. The graduation keynote speaker was Deng Jongkuch, author of *A Story*

of Hope: The Journey of a Lost Boy of Sudan. Student highlights included MVCA's senior Valedictorian - a 16-year-old who graduated early. Another highlight included a performance by a senior student who, as part of her Innovation Research Project, wrote and produced a song. Mr. Rodriguez shared that the Kawthar Al-Haqq Award of Perseverance was presented to a deserving student who had overcome a traumatic brain injury. Furthermore, Mr. Rodriguez shared that a special graduation ceremony was held for a student at the MVCA Grand Rapids' office for a student who was unable to attend the main ceremony. MVCA Graduation 2023 was a great success.
